

The undersigned officer, being duly sworn, states upon information and belief that:


COUNT I
(Attempted Theft by Deception 17-A M.R.S.A. §354(1)(A) & (B)(4))
SEQ NO. 008434 ATN: 961964A/ CTN: 001

On or about April 18, 2012, in the City of Augusta, County of Kennebec, State of Maine, Defendant Michael G. Hein (“Defendant”) did attempt to commit the crime of theft by deception against the State of Maine by intentionally engaging in conduct which, in fact, constituted a substantial step toward the commission of the crime of theft by deception, with the intent to complete the commission of that crime, in that he did attempt to obtain property of the State of Maine, such property consisting of money in the form of public campaign finance funds, with an aggregate value in excess of \$1,000, with the intent to deprive the State of Maine thereof, and as a result of deception, in that the Defendant did intentionally create or reinforce the impression that he had obtained qualifying contributions from the personal funds of 67 contributors in support of his

request for public campaign funding, which impression was false and which Defendant did not believe to be true, all in violation of 17-A M.R.S.A. §354(1)(A), (B)(1) and (2)(A).
